
#### **Background and Qualifications**


- My research interests as a Ph.D. student in Economics are centered around the interaction between fiscal and monetary policy in determining the state of the economy.

- As an undergraduate, I led fundraising efforts for my student-run debate team, which received no university funding. By connecting our debaters with high school debate teams in need of judges, I successfully raised \$1,800, demonstrating my ability to secure external funding and manage financial resources effectively.
- I have a strong commitment to fiscal discipline, and I will ensure that the independence of the IU GSPG is not threatened by university interventions due to budget mismanagement.

#### Plans for the Upcoming Year

As Treasurer, I will focus on the following key initiatives:

1. **Enhancing Budget Transparency**: I will ensure that the GPSG budget proposals are fully accessible and transparent to the GA. It is important that legislators understand not only next year's budget but also the budgets for prior years. Legislators should know if our budget proposal is unprecedented.
